Chapter XIII-D is revised in response to amendments to Iowa Code section 321.180B which were effective July 1, 2008. Manual changes provide caseworkers guidance on policy, procedure, and use of Department of Transportation form 430018, *Parent's Written Consent to Issue Privilege to Drive or Affidavit to Obtain a Duplicate*.

Procedures for adoption are also removed and replaced with cross-references to Employees' Manual Chapters 18-F and 18-F(1).
