- W Foster care, PMIC, or MHI, ages 0-9 (inclusive), Iowa Plan
- X Foster care, PMIC, or MHI, ages 10-22 (inclusive), Iowa Plan

This chapter has been converted to new manual format and is revised to:

- Correct various formatting and typographical errors for consistency.
- Add the MMCR = Medicare Data Main Menu, which allows workers to view beneficiary data exchange between Department of Human Services and the Centers for Medicare and Medicaid Services regarding Medicare Parts A, B, C, and D benefit plan enrollment information. MMCR menu options include: BSEL, SRCV, and PTDE.
- Replace references to "client" or "recipient" with "member" or "beneficiary," as appropriate.
- Reflect changes to "HREF = Referral System" section which include the following:
  - Adding Estate Recovery referral screen information and definitions to the "HREF = Referral System" section. This includes the HREFES1, HREFES2, and HREFES3 screens.
  - Updating the HREF Referral Menu screen to show new UNVERIFIED INCOME and ESTATE RECOVERY REFERRAL STATE ID: fields.
  - Updating the HIRFDET = HIPP Policyholder Referral Information screen, definitions, and HIPP Referral Case Actions to reflect addition of EMP CITY: field.
  - Updating then HWKR Identification of People in the Home screen, definitions and *hawk-i* referral case actions to reflect addition of ID: and STATE EMP: fields.
  - Adding the new HWKR Unverified Income For Excluded Children screen information and update *hawk-i* referral case actions to reflect the new screen.
  - Updating the HWKR History screen and definitions to reflect addition of ID: and STATE EMP: fields and references to the Unverified Income for Excluded Children screen.
  - Updating the *hawk-i* referral case actions to reflect processing changes due to implementation of IABC Real Time.

- Remove the name of Iowa Plan provider as a specific provider name is not necessary.
- Remove information regarding managed health care notices and the ABC system. These notices are issued by IME, not by the ABC system.
- Remove "MEPD Billing Screens" section to PREM billing screens to reflect system and menu changes. Other changes include:
  - Adding the new Premium System Main menu, which displays MEPD Coverage Group Menu, PREF, RETR options.
  - Adding the new MEPD Coverage Group Menu, which displays SUMM, DETL, STMT, MOAK, and PVAL options.
  - Moving sections to reflect new menu structure.
  - Adding MOAK = Monthly Summary Counts screen and definitions.
  - Adding PVAL = Monthly Valid Premiums screen information.
  - Removing AREF and RREF fields from PREF screen and definitions.
  - Adding COV GROUP field to PREF screen and definitions.
  - Adding valid codes for MEPD RETR ETHNIC field.
- Update "MIPS Billing Screens" section as follows:
  - Change PF13 function key descriptor from RSN CODES to CODES HELP on MIPS Summary and HAPL = HIPS Applied Hardship screens.
  - Add HARDSHIP RSN field and codes to MIPS Detail screen and descriptions.
  - Change METH field name to method on PREF screen.
  - Add valid codes for MIPS RETR ethnic field.
  - Change MOAK REFUNDS field to SEPARATE MANUAL and AUTOMATIC REFUND fields instead of one JOINT REFUND field.
  - Remove OTHER MAILERS field and description from MOAK screen.
  - Add MEDICAL ID CARDS PRINTED field and description to MOAK screen.
- Reflect changes to the SSNI = Medicaid Eligibility File which include:
  - Adding blended aid types 87F, 8PF, and 8BF to chart.
  - Adding new "V" code to INS field description.
  - Adding BUY-IN, BUY-OUT, SCREENING INITIAL, SCREENING CURRENT, and SCREENING INITIAL and CURRENT ONE-BYTE field descriptions and applicable codes.
  - Adding HEALTH INS, PACE, and MFP fields, descriptions, and codes to the DETL MTH screen information.
