Summary

- ♦ The sentence "This designation is not displayed on the SDXD screen" has been removed from TREAS on page 5 because this information is now displayed in certain situations.
- ♦ A new field, TREASURY DATE, has been added to all four SDXD display screens, pages 48 through 50. This designation will appear only when the screen is updated from a treasury tape.
- ♦ New fields, TELEPHONE NUMBER and ZIP + 4, have been added to the SDX form 8036 and are reflected on the sample SDX form 8036 (between pages 2 and 3), and on page 9.
- ♦ A new field, TELEPHONE, has been added to the SDXD Name/Address screen (PF2) and is reflected on page 48.
- ♦ The statutory reference for parole status under the ALIEN CODE has been corrected, and the word "legal" has been changed to "lawful" on page 9.
- ♦ Additional RACE codes have been added on page 12.
- ♦ A new RECIPIENT TYPE, Ineligible Spouse, has been added on page 14.
- ♦ A new PAYMENT STATUS code, N18, has been added on page 19.
- ♦ A new PAYMENT STATUS code, S01, has been added on page 21.
- ♦ A new THIRD PARTY CODE, Q, has been added on page 25.
- Five new APPEAL CODES, K through O, have been added on page 27.
- ♦ Three new UNEARNED INCOME TYPE codes, G, O, and W, have been added on pages 34 and 35.
- ◆ Two new fields, ZEBLEY CODE and INSTITUTIONALIZATION CODE, have been added to the SDX display screen and form 8036 and are described on the sample SDX form 8036 (between pages 2 and 3), and on page 46.

- ♦ A new field, INSTITUTIONALIZATION CODE, has been added to the SDXD display screens reflected on page 50.
- ADC has been changed to FIP and the manual reference has been updated on page 43.
- ♦ On pages with revisions, the spelling of the word "cancelled" has been changed to "canceled" to conform with X-Pert; roman numeral manual references have been updated; manual references have been updated. Several cosmetic changes have been made throughout the chapter.
- ♦ The numbers in parenthesis after the data element names have been changed to reflect the new Social Security Administration SDX record format. (This is for central office use only.)

Summary

With the implementation of X-PERT, the SDX process has been changed. Information about the changed process has been included in this revision as well as minor revisions to clarify existing procedures.

The Department is implementing an automated process to send and track the receipt of the MA-2124 form, *Medicaid Information Questionnaire for SSI Persons*, for certain new SSI cases and to establish Medicaid eligibility when no further information is needed from the client. This process will occur whether or not you are using X-PERT for your eligibility work.

A new screen on XABC, called SDXT, has been developed for tracking the receipt of the MA-2124. Another new feature is that this screen will cause mainframe to send form 470-3193, *SSI Medicaid Reminder*, to the client when the MA-2124 is not returned.

Enter the receipt date of the MA-2124 on the SDXT screen even if you do not use X-PERT for your eligibility work.

When your case is not selected for the automated process and you do not use the X-PERT process yet, ABC is available for you to record the Medicaid eligibility. Also, you can enter "V" in the retroactive Medicaid field on TD05 to send the *Reminder* to your client when you have previously sent the MA-2124 and it has not been returned.

Summary

Revisions to this chapter:

♦ Revise the explanation of payment status codes N31, N32, N42, and N43 to assist workers in determining when to deny Medicaid based on an SSI denial. Changes clarify when medical impairments have been evaluated in the disability process for SSI, so workers can correctly determine when an MEPD application should be denied based on an SSI disability denial.

In determining disability under the Medicaid for employed people with disabilities (MEPD) coverage group, a disability determination is completed even if the person works. If the person is determined to have a severe medical impairment but does not meet or equal a listing of medical impairments, the next two steps of the disability determination process look at a person's ability to work ("substantial gainful activity").

However, if the person's impairment does not meet the listing, the person is not considered disabled for MEPD, regardless of whether there is an ability to work.

- ♦ Update the example of SDX Form 8036 and the screen on page 49, as well as the field descriptions, to reflect the addition of two new fields for the appeal decision date and code.
- ♦ Add payment status codes E02, M02, N22, N23, N25, N52, N53, N55, N56, T32, and T33, and their definitions, on pages 17 through 22.
- ♦ Change the appeal codes and definitions.
- Correct the reference to 8-F, on page 2.
