Summary

This manual clarifies how reports containing IRS data are to be stored. The SSA Earnings and Pension Report and the IRS Match report will no longer be filed in the case record. These two reports shall be kept in a locked storage area, such as a cabinet or file drawer.

The retention time has been shortened to one year for the two IRS reports listed above. Central Office stores these two reports on microfiche and retains the fiche for two years.

The county offices shall maintain a log documenting the receipt of IRS data. A log shall also be kept when any IRS data is destroyed. A DHS employee must observe the destruction of all IRS data.

When a case record is being transferred to another county office, remove any IRS data which has already been acted upon by the IM worker. Note the results of that investigation in the case record. If the IRS data has not been acted on, the sending county shall ensure that the IRS data is double-sealed in an envelope and marked "confidential" on the outside, before sending it to the new county.

The manual also clarifies that the intentional disclosure of IRS data is a felony and may be punishable by both a fine and imprisonment.

These changes are required for compliance with IRS regulations.
