Summary

The format and language of Comm. 96, *Dependent Adult Protection Handbook*, have been updated. The Handbook has three sections, on definitions, intake, and determination of report conclusions. A tool for assessment of dependency has been added.

The following definitions have been added: assault, assessment, brothel, caretaker, counselor or therapist, evaluation, financial exploitation, mental health service, physical injury, sexual exploitation, sexual conduct, and unreasonable confinement or punishment.

The *Dependent Adult Abuse Services Intake*, form SS-1638-0, was revised in 1995. Caretaker and alleged perpetrator were combined into one section. The form was updated and rearranged to facilitate taking reports. The instructions reflect the changes.

The *Request for Dependent Adult Abuse Information*, form SS-1114-0, was revised in 1997. This form is used by persons who have authorized access to dependent adult abuse information to obtain information from the registry.

The *Record Check Evaluation* was revised in 1997. This form is used by persons who have a criminal or abuse history to have that information evaluated for the purpose of continued employment.

Summary

The *Request For Dependent Adult Abuse Information* has been changed by adding space for the person who is being checked to include social security number, date of birth, maiden name or alias, and address. An electronic template for this form is available in Outlook public folders. The instructions for the form on page 18 are changed to include the additional information.

Summary

This letter adds two items to the dependent adult services appendix:

- New form 470-3860, *Dependent Adult Abuse Checklist for Facility, Agency or Program*, is added to assist protective services staff in advising agency administrators what actions are necessary when abuse of a dependent adult is reported in a facility, agency, or program.
- Comm. 118, Dependent Adult Abuse: A Guide for Mandatory Reporters, has been revised to reflect 2001 legislative changes. The Department will not order printing of this Guide at Iowa State Industries (although a limited supply of the previous version remains available). People may download and print the Guide from the Department web site.

- *Registry Extension*, form 470-0627, was revised to add a space for the supervisor's signature. The supervisor has the final authority to approve an extension to the timeframes to complete a ten-day report.
- *Adult Protective Notification*, form 470-2444, has been revised to clarify how forwarded assessment reports are handled.
- Child and Dependent Adult Abuse Contact Roster, form 470-0675, has been revised to replace the regional administrators and county human services area administrators with service area managers.
- Dependent Adult Protective Services Registry Sheet, form 470-2731, has been revised to remove items not used by the Registry.

- Update Comm. 118, Dependent Adult Abuse: A Guide for Mandatory Reporters, to:
 - Change the date on the Cover to signify the handbook has been updated with 2005 changes in law.

- Space was added to explain the reporter's assessment of the dependent adult's abilities or limitations.
- The "Allegations" category was separated into reports that involve a caretaker and require an evaluation and reports that do not involve a caretaker and require an assessment only of the dependent adult. If the box is checked indicating the alleged abuse was the result of actions of the dependent adult and therefore an assessment only, the tab button automatically drops down to "Allegations."
- The abuse codes for the "Allegations" category was revised from codes to boxes to indicate the type of abuses reported.
- The new category of "Barriers" was added to explain the barriers the reporter believes contributed to the alleged abuse and space to explain them.
- Added to the "Collateral Sources of Information" category, is "Name of Guardian, Conservator or Other Person Responsible for Dependent Adult."
- A drop-down box was added to indicate the profession of the mandatory reporter.
- The name of the section previously titled "Contact and Preliminary Report Information" was changed to "Central Registry Background Check."
- The space for "Date Time Assigned" was changed to "Intake Decision Date/Time."
- A drop-down box was added to indicate the reason the report of abuse was rejected.
- Places were added to check if the dependent adult has a background in dependent adult abuse, an open service in ISIS or a criminal background. Places were added to indicate if the person suspected of abusing the dependent adult has a criminal or dependent adult abuse background.
- The category, "Actions taken to protect adult:" was moved to the narrative section in form 470-0688, *Dependent Adult Abuse Evaluation or Assessment Report*.

- Form 470-0657, *Dependent Adult Abuse Intake*, is revised by adding "sexual exploitation" to the list of allegations. Also a "Worker Safety Alert" notice is added to the top of the first page. Clicking on the button at the bottom of page 4 can activate it.
- Form 470-0688, Dependent Adult Abuse Evaluation or Assessment Report, is revised by adding "sexual exploitation" as a type of founded abuse and by adding the finding of "Assessment – The abuse is confirmed, not registered."
- Form 470-2444, *Adult Protective Notification*, is revised so when you type in the Registry Number on page one it automatically is entered on page two.
- Form 470-0675, Child and Dependent Adult Abuse Contact Roster, is obsolete and is deleted.
• New form 470-4531, *Authorization for Release of Dependent Adult Abuse Information*, is added for people who want to complete background checks on prospective employees but do not have access to dependent adult abuse information.

The subject gives the requester authority for the record check by signing the form. The only information the requester receives is whether the person's name is on the Registry for abusing a dependent adult. This form will be available on the DHS web page.

- Form 470-0681, *Dependent Adult Abuse Reporting Form*, is revised by adding "sexual exploitation" as a category of abuse reported and founded.
- Comm. 96, *Dependent Adult Protective Handbook*, is revised by changing "sexual exploitation of a resident of a health care facility" to "sexual exploitation of a dependent adult by a caretaker."
- Comm. 118, Dependent Adult Abuse, A Guide for Mandatory Reporters, is revised by: updating the introduction; adding the new form 470-4531, Authorization for Release of Dependent Adult Abuse Information, and adding changes to policy pursuant to 2008 Iowa Acts, House File 2591, which enacts a new Iowa Code Chapter 235E, "Dependent Adult Abuse," effective July 1, 2008.

This legislation authorizes the Department of Inspections and Appeals (DIA) to complete evaluations of abuse reported about dependent adults who reside in:

- Health care facilities licensed under Iowa Code Chapter 135C;
- Hospitals defined in Iowa Code section 135B.1;
- Elder group homes defined in Iowa Code section 231B.1;
- Assisted living programs certified in Iowa Code section 231C.1; and
- Adult day programs defined in section Iowa Code 231D.1.

Iowa Code Chapter235B authorizes DHS to complete evaluations and assessments on all dependent adults not residing or receiving services in the settings listed above. To address these changes, the following changes were made in Comm. 118:

- Instructions for mandatory reporters are revised to indicate which health care facilities and programs are covered by DIA.
- Instruction for reporting abuse are revised how to report abuse to each agency, including a map and list of DHS intake unit phone numbers and fax numbers.
- Definitions used by DIA in evaluating abuse allegations are added.
- The definition of "assault" used by DHS in 441 Iowa Administrative Code 176.1(235B) is added.
- The category of abuse, "sexual exploitation of a resident of a health care facility" is amended to "sexual abuse of a dependent adult by a caretaker."

- Comm. 195, *Dependent Adult Protective Services, Facility, Agency, and Program Evaluation Handbook*, is also revised to reflect changes pursuant to 2008 Iowa Acts, House File 2591, assigning responsibility for more evaluations in programs and facilities to DIA, as described above. Changes to the handbook include:
 - A new section on the authority of DIA to complete evaluations of abuse in health care facilities, hospitals, elder group homes, assisted living programs, and adult day programs.
 - Revised instructions on which agency to report abuse.
 - Revisions to change the category of abuse "sexual exploitation of a resident of a health care facility" to "sexual abuse of a dependent adult by a caretaker."
 - An update to the chart on which types of agencies are governed and regulated by what entity and who DHS needs to contact when initiating an evaluation or assessment of abuse in a facility, agency, or program.
 - An update to the DIA web page information and phone number.
 - Addition of suggestions on stressing the risks of liability if risk factors are not addressed when conducting an evaluation of safety of an alleged dependent adult in a facility or program.
