#### **Summary**

This chapter is revised to reflect changes in policy pursuant to changes in 2008 Iowa Acts, House File 2591, effective July 1, 2008, which affect intake on dependent adult abuse.

The Department of Inspections and Appeals (DIA) will now have responsibility for evaluating reports of dependent adult abuse committed by staff members or employees in the following programs, in addition to health care facilities defined in Iowa Code section 135C and hospitals defined in 135B:

- ♦ Elder group homes defined in Iowa Code section 231B.1;
- Assisted living programs certified in Iowa Code section 231C.3; and
- ♦ Adult day service programs defined in Iowa Code section 231D.1.

DHS will continue to evaluate allegations of abuse when the person suspected of abusing a dependent adult is not a staff member or employee or the dependent adult is out of the facility or program and the caretaker is not a staff member or employee. DHS will also continue to assess the immediate threat to the physical safety of dependent adults after hours, on weekends and on holidays.

The allegation of "sexual exploitation of a dependent adult in a health care facility" has been changed to "sexual exploitation of a dependent adult by a caretaker".

#### Summary

This chapter is revised to:

- Add a new section concerning caretakers serving as power of attorney for health care for dependent adults who may be violating the law. Unless the caretaker is related to the dependent adult within the third degree of consanguinity, by law the caretaker may not provide care and also serve as power of attorney for the dependent adult.
- ♦ Provide link to Employees' Manual, Title 16, Comm. 96, *Dependent Adult Protection Handbook* following the section on criteria to accept a report of alleged abuse.
- ♦ Change the policy on notifying reporters of abuse. The new policy is the intake worker will send form 470-3944, *Dependent Adult Abuse Notice of Intake Decision*, on every report of abuse within five working days, whether the report of abuse is accepted for evaluation or assessment or rejected.
- Add a new section on making referrals at the time of intake to Department service workers and licensing agents when ISIS indicates there is an open service on the dependent adult.

## **Summary**

Chapter 16-G(1) is revised to:

- ♦ Add 2009 Iowa Acts, Senate Files 484 and 438, to the legal basis for dependent adult protection policy.
- ♦ Add new definition of "boarding home" and new policy for participating in multidisciplinary teams coordinated by the Department of Inspections and Appeals to respond to allegations of abuse of dependent adults living in boarding homes.
- ♦ Change definition of "sexual exploitation of a dependent adult by a caretaker" to:
  - Remove the factor that the sexual exploitation was "for the purpose of arousing or satisfying the sexual desires of the dependent adult or caretaker"; and
  - Include in the definition "transmission, display, taking of electronic images of the unclothed breast, groin, buttock, anus, pubes or genitals for a purpose not related to treatment or diagnosis or as part of an on-going assessment, evaluation, or investigation."
- ◆ Clarify that all mandatory reporters shall be considered mandatory reporters even if another mandatory reporter has already reported the incident the person is reporting. All mandatory reporters shall be sent form 470-3944, *Dependent Adult Abuse Notice of Intake Decision*.
- Clarify that if the intake worker discovers from a background check in ISIS that the dependent adult has a DHS service worker or a targeted case manager, the intake worker may want to consider an in-depth intake because that person is a mandatory reporter of dependent adult abuse.
- ♦ Require sending form 470-4800, *Notice Concerning Suspected Abuse*, to notify a DHS service worker or HCBS specialist that the Intake Unit has accepted a report of abuse on a dependent adult.
