This general letter defines the new Chapter 5-F, ***Iowa Family Planning Program (FPP)***. Due to state legislation, the Department was required to discontinue the Medicaid Iowa Family Planning Network (IFPN) program and establish the state Family Planning Program effective July 1, 2017.

The Family Planning Program replicates the eligibility requirements and other provisions included in the Medicaid Iowa Family Planning Network (IFPN) program in effect on June 30, 2017.
