SUBJECT: Employees' Manual, Title 7, Chapter E, *Income*, Contents (page 3), revised;  
pages 1, 2, 25, 26, 28, 33, and 35 through 38, revised; and page 38a, new.

### **Summary**

Page 35 is revised to allow a deduction for legally obligated child support payments. The deduction is allowed when the payments are made by a household member and paid to someone living outside the household.

Child support can be ordered as cash support, medical support, or other payments like medical insurance and vendor payments for expenses like rent. Only the amount that is actually being paid is allowed as a deduction. However, do not allow a deduction for any amount that exceeds the court ordered amount.

Voluntary child support payments, alimony or other payments like those made as a property settlement are not allowed as a deduction.

Other pages are revised for minor corrections and due to repagination.

### **Effective Date**

This material is effective for actions taken on or after October 1, 1995, on applications and recertifications, starting with October benefits. This material is effective for ongoing cases, beginning October 1, 1995, no later than at recertification or when there is a reported change, whichever is earlier.

### **Summary**

This change is being made to reduce the standard deduction from \$138 to \$134.

October 1, 1995, COLA changes increased the standard deduction to \$138. On October 21, 1995, the Fiscal Year 1996 Agriculture Appropriations bill became law. This bill mandates the standard deduction be reduced from \$138 to \$134 (back to the previous level).

It also incorporates the October 1, 1995, heating and air-conditioning SUA of \$222 per month per household into the manual. (The revised shelter deduction of \$247 is already in the manual.)

### **Effective Date**

The change in the standard deduction is effective no later than for all December 1995 benefits issued on or after December 1, 1995.

SUBJECT: Employees' Manual, Title 7, Chapter E, *Income*, Contents (pages 3 and 4), revised; and pages 23 through 28, and 34 through 45, revised.

### Summary

This chapter revision changes the policy on utility deductions and sharing utility expenses. Households will no longer have the choice of, nor will they receive, an actual utility expense.

Households that have utilities included in their rent and pay the landlord a fee or an amount for excess utility cost for use of certain utilities (which can include heat or air conditioning) will receive the little standard utility allowance.

When a food stamp household lives with and shares utility expenses with other food stamp households or with non-participating people, each food stamp household will receive one share of the appropriate utility standard and all non-participating people together will be considered one share of the appropriate utility standard.

The federal interpretation on whether condominium fees are allowable shelter costs has changed to allow these costs.

### Effective Date

The utility change is effective with all benefits issued for May 1, 2000.

Allow condominium fees as a shelter expense upon receipt of this manual at application, recertification and when a move is reported.

BCW1s with a phone code of Y or N, utility code of A, and amounts of other than zero, \$117.50 or \$57.50 must be converted to the new codes under the revised policy for food stamp benefits issued May 1, 2000.

You will receive a printout of cases that you must convert (those coded with phone code Y or N, utility code of A and amounts other than zero, \$117.50, or \$57.50). The printout is divided into three parts.

- ◆ The first part lists cases coded with utility amounts greater than \$115 which are potentially affected by timely notice date. You must review these cases and change the utility code by timely notice day in April if the utility code change will cause a reduction in benefits.
- ◆ The second part lists cases coded with utility amounts less than \$115 that are not zeros or \$57.50. These cases have a potential for benefits to increase. They should be converted so that May benefits reflect the change.
- ◆ The third part lists all the cases the system converted and the utility code that case now has on the BCW1.

**Note:** Any action you take to cause a May calculation for cases coded with utility code of A and amounts other than zero, \$117.50 or \$57.50 will cause a system error if you don't update the May BCW1 when you do your system entries.

## GENERAL LETTER NO. 7-E-74

ISSUED BY: Bureau of Food Stamps, Division of Economic Assistance

SUBJECT: Employees' Manual, Title 7, Chapter E, *Income*, Contents (page 1), revised;  
and page 4, revised.

### Summary

Page 4 is revised to exempt as income for determining food stamp eligibility and benefits the census earnings received by temporary workers during the budget months of April 2000 through January 2001, for work performed for the Bureau of the Census for Census 2000.

This policy change does not affect the earnings of permanent employees of the Bureau of the Census. The wages of permanent employees of the Bureau of the Census continue to count for determining food stamp eligibility and benefits.

The census earnings of temporary workers received during the budget months of February and March 2000 are not exempt as income for determining food stamp eligibility and benefits.

The pay statements of temporary employees hired and paid by the Bureau of the Census will have the notation "Census 2000" on the statement.

Some people who work for temporary employment agencies may be placed with the census as a job assignment. Pay stubs from temporary agencies may or may not show that the earnings are for census work. If earnings paid by a temporary employment agency are identified on the check stub or by the client as being paid for census work, exempt the income as specified in this General Letter.

If there is no indication given by the client or on the check stub that wages paid by a temporary employment agency were for census work, consider the person to be employed by the temporary agency, not the Census Bureau. It is the responsibility of the person to identify and report the earnings as census income to get the exemption. In this situation, it is appropriate to count the wages as income.

Reimbursements for travel expenses are exempt under regular food stamp program policy.

Allow a deduction for child care necessary for temporary census work, even if the census earnings are the only earnings in the household.

Temporary census work is considered regular employment when applying the work registration, voluntary quit, voluntary reduction in hours of work, ABAWD work requirements, and FSET exemption policies.

To implement this policy:

- ◆ For **ongoing retrospectively budgeted cases**, do not count census earnings of temporary workers that are received starting with the budget month of April when determining eligibility and benefits for food stamps for the June benefit month, and for ongoing budget months through the budget month of January 2001. This policy only applies to earnings received starting with the budget month of April. Do count February census earnings for the benefit month of April, and do count March census earnings for the benefit month of May.
- ◆ For **ongoing prospectively budgeted cases**, do not count census earnings of temporary workers that can be anticipated to be received in the month of April.
- ◆ For **prospectively budgeted applications**, do not count the census earnings of temporary workers that are received or are anticipated to be received beginning the budget month of April when determining food stamp eligibility and benefits.
- ◆ For **retrospectively budgeted applications**, do not count April census earnings for the benefit month of June. This policy applies only to census earnings of temporary workers received during April 2000 through January 31, 2001. Therefore, do count census earnings of temporary workers that were received in the month of February for the benefit month of April, and those received in the month of March for the benefit month of May.

## **Reporting Requirements**

Monthly Reporting Households: Do not require households to report monthly solely because a member received exempt census earnings as a temporary worker. If a household is a monthly reporting household, do not consider a monthly report incomplete for not reporting or verifying temporary census earnings that are exempt.

Non-Monthly Reporting Households: These households are not required to report the exempt census earnings of temporary workers.

On page 6, the income type "Child's Earnings" is revised to clarify that the household member aged 17 or younger must be a student attending:

- ◆ Elementary or high school,
- ◆ Home schooling or
- ◆ GED program recognized, operated, or supervised by the state or local school district to have their earned income excluded.

On pages 6 and 7, the income type “Child Support” is revised to clarify that child support of a FIP recipient that is released to the food stamp household which must be retained by the Child Support Recovery Unit to comply with FIP requirements is not counted as income.

Child support of a FIP recipient that is released to the food stamp household that does not have to be retained by the Child Support Recovery Unit to comply with FIP requirements is counted as income. The child support that is counted includes support released for a month of FIP suspension and an overage when the child support exceeds the FIP assistance paid out.

On page 38, the deduction “Child Support Payment” is revised to clarify that a deduction is not allowed for income tax refund intercept. Allow a child support deduction for support paid by a household member to an agency or person outside the household, even if the child or the other parent are in the same food stamp household as the person paying the support. Allow this deduction if the support payments are not returned to the household.
