# **Summary**

The Personal Responsibility and Work Opportunity Act (Public Law 104-193) which was enacted effective August 22, 1996, amends the Social Security Act to remove the prohibition on IV-E funding when a child is placed in a for-profit facility. IV-E funding will be available for Medicaid and maintenance costs beginning October 1, 1996, when a IV-E-eligible child is in a for-profit placement.

The reference to IV-E policy for JCO cases before August 1, 1995, is being removed so the manual reflects only current policy.

# **Implementation**

FACS will generate an Exchange of Information (Report S472N111-01) indicating that the child is now in a IV-E placement. Complete an automatic redetermination for these cases. If appropriate, change the aid type to reflect IV-E eligibility.

# Summary

This chapter is revised to:

- ◆ Clarify that IV-E eligible children must be made automatically eligible for Medicaid without requiring a separate application or annual Medicaid review. However, an application or review form may be requested to gather information needed to determine whether the child is IV-E eligible and to facilitate the child's Medicaid enrollment.
- ♦ Clarify that non-IV-E eligible children with an adoption assistance agreement from a reciprocity state must be made automatically eligible for Medicaid without requiring a separate application. However, an application may be requested to facilitate the child's Medicaid enrollment.
- ♦ Clarify that children are provided Medicaid under the terms of their adoption subsidy agreement even if no adoption subsidy payment is being made.
- ♦ Clarify that if another state opts to extend IV-E eligibility to children receiving foster care, subsidized guardianship, or subsidized adoption up to age 19, 20, or 21, Iowa Medicaid must be provided regardless of Iowa's age limits for providing foster care, subsidized guardianship, or subsidized adoption.
- ♦ Add links to service chapters for additional information about procedures for providing Medicaid for children in interstate cases.

This revision reorganizes some sections of the chapter into a new policy format as follows:

- ♦ The "Policy" section is the Department's official interpretation of a federal law, federal regulation, federal clarification, or state administrative rule. It includes the legal reference. This is the citation of the legal basis for the policy. Policy is brief, and follows the quoted legal citation as closely as possible.
- ♦ A "Procedure" section follows. This provides instruction and procedure for implementing policy. The Procedure section also provides more detail to provide an understanding of the policy's intent.

- ♦ A "Comment" section provides additional related information.
- ♦ Examples are placed at the end of sections when necessary to prevent interruption of the flow.
