# NOTICE OF DIRECTION OF PAYMENTS PAYEE NOTICE

Per Iowa Code Chapter 252B Section 16, this Notice is the equivalent of a court order requiring payments to be sent to the Collection Services Center.

## WHAT THIS NOTICE MEANS TO YOU

Because the Child Support Recovery Unit (CSRU) is now providing services for your child support case or your payments are received from an income withholding order, the person who pays support to you is now sending these payments to the Collection Services Center (CSC).

CSC is a centralized payment processing center for receiving, recording, and disbursing court ordered support payments. CSC issues a state of lowa warrant (check) to you for the amount received unless you receive FIP benefits or a portion of the payment is owed to the state.

You may choose to have your payment transferred to your bank or credit union account through automatic deposit rather than receiving a check from CSC by mail. Call 1-888-229-9223 for more information if you are interested in this option, (Des Moines area residents should call 242-5530.)
