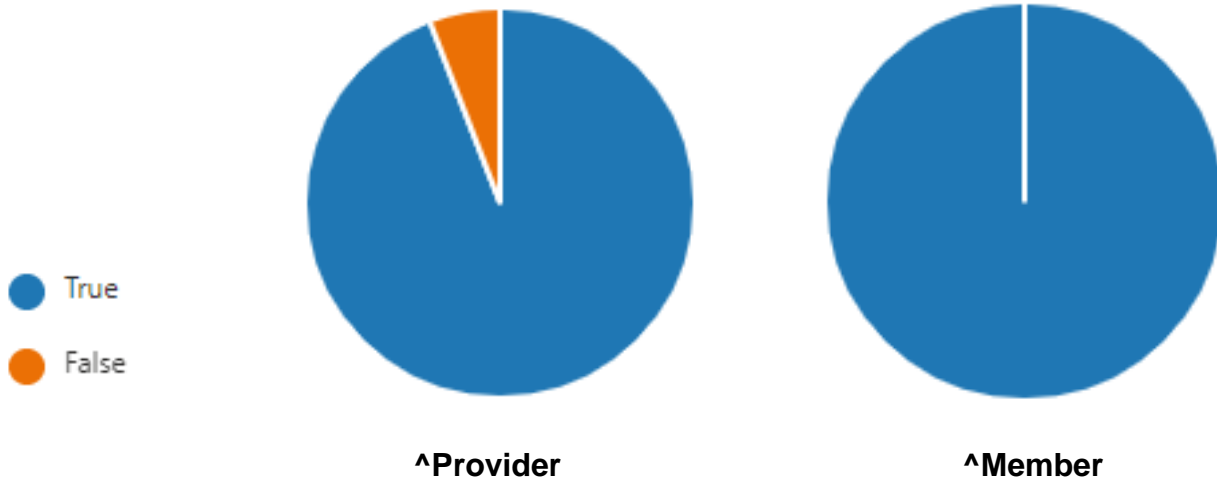

### Town Hall Survey Feedback on Usefulness of Town Hall

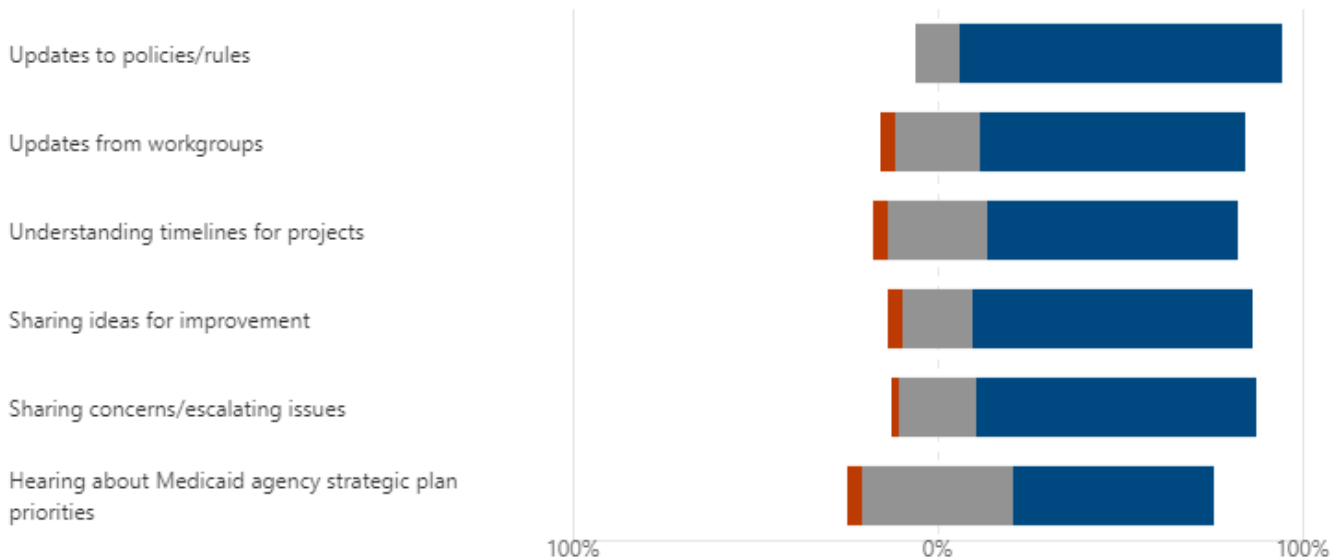


### Town Hall Survey Feedback on Whether Issues are Resolved Timely (Member)



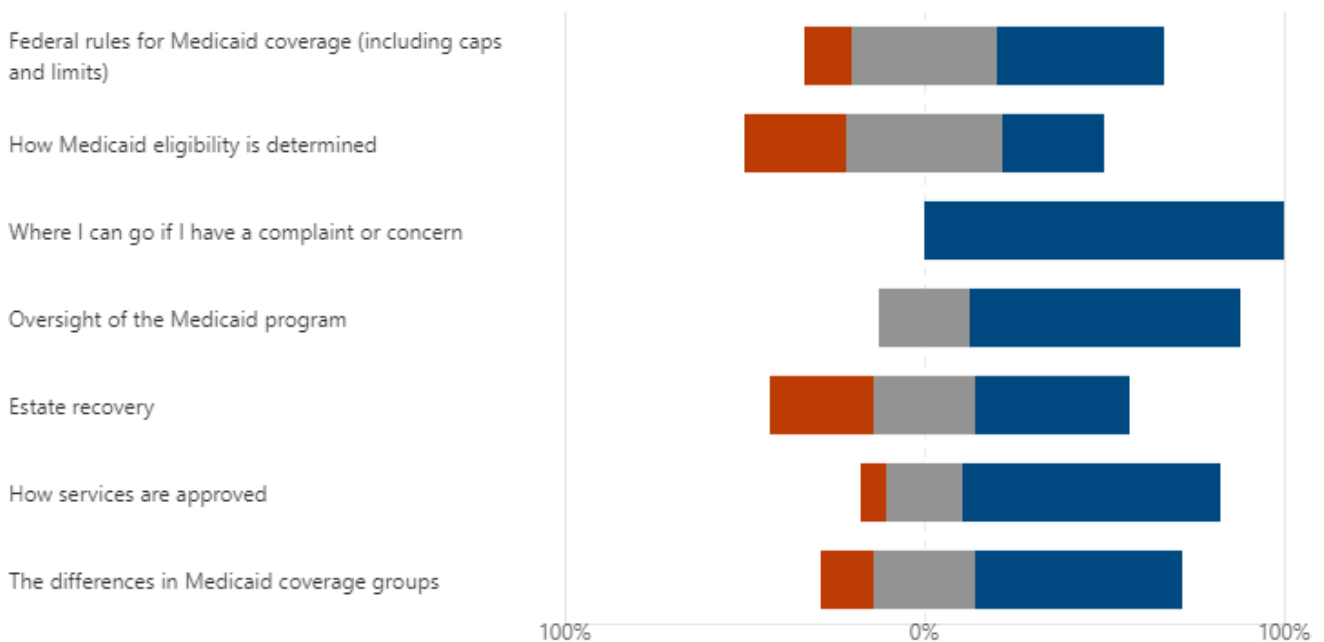
