CITATION AND WARNING

Pursuant to the provisions of Iowa Code Sections 17A.18, 147A.7, and Iowa Administrative Code (I.A.C.) 641—131.7 the Iowa Department of Public Health is proposing to issue a **Citation and Warning** to the emergency medical care provider certification identified above.

The department may issue a citation and warning when an emergency medical care provider has committed any of the following acts or offenses:

Fraud in procuring certification or renewal including, but not limited to:

(2) False representation of a material fact, whether by word or by conduct, by false or misleading allegations, or by concealment of that which should have been disclosed when making application for a certification in this state.

Iowa Code Section 147A.7(1)d and IAC 641—131.7(3)d

Violating a statute of this state, another state, or the United States, without regard to its designation as either a felony or misdemeanor, which relates to the provision of emergency medical care, including but not limited to a crime involving dishonesty, fraud, theft, embezzlement, controlled substances, substance abuse, assault, sexual abuse, sexual misconduct, or homicide. A copy of the record of conviction or plea of guilty is conclusive evidence of the violation.

The following events have resulted in issuance of this proposed action:

On June 26, 2001, you were convicted of endangerment of a child. You were placed on probation until June 25, 2003 and fined \$200.

In 2002, you denied ever being convicted of a misdemeanor crime when applying for reciprocity as an emergency medical care provider with the Department.

On January 7, 2008, you denied ever being convicted of a misdemeanor crime when completing the student registration for an EMT-Intermediate course.

On April 8, 2008 you denied ever being convicted of a misdemeanor crime when submitting a certification application for EMT-Intermediate level.

You are hereby **CITED** for failing to report a criminal conviction to the Department and for violating a statute of the State of Minnesota. You are **WARNED** that failing to fully disclose your criminal background in the future or violating any other law related to the practice of EMS may result in further disciplinary action, including suspension or revocation of your emergency medical care provider certification.

You have the right to request a hearing concerning this notice of disciplinary action. A request for a hearing must be submitted in writing to the Department by certified mail, return receipt requested, within twenty (20) days of receipt of this Notice of Proposed Action. The written request must be submitted to the Iowa Department of Public Health, Bureau of Emergency Medical Services, Lucas State Office Building, 321 E 12<sup>th</sup> St, Des Moines, Iowa 50319. If the request is made within the twenty (20) day time limit, the proposed action is suspended pending the outcome of the hearing. Prior to or at the hearing, the Department may rescind the notice upon satisfaction that the reason for the action has been or will be removed.

If no request for a hearing is received within the twenty (20) day time period, the disciplinary action proposed herein shall become effective and shall be final agency action.
