ENDNOTES:

¹ "Mentally incapacitated" means temporarily unable to control conduct due to influence of a narcotic, anesthetic, or intoxicating substance.

- ² "Physically Incapacitated" means unconscious, asleep, or otherwise physically limited.
- ³ "**Physically helpless**" means the child has a bodily impairment or handicap that substantially limits ability to resist or flee.
- ⁴ This excludes reasonably foreseeable incidents of sport or social activity or school employees who reasonably intervene in a fight or struggle.
- ⁵ "Counselor or therapist" means a physician, psychologist, nurse, professional counselor, social worker, marriage or family therapist, alcohol or drug counselor, member of the clergy, or any other person, whether or not licensed or registered by the state, who provides or purports to provide mental health services.
- ⁶ "School employee" means any of the following:
- A person who holds a license, certificate, or statement of professional recognition issued under Iowa Code chapter 272.

- A person who holds an authorization issued under Iowa Code chapter 272.
- A person employed by a school district full-time, part-time, or as a substitute.
- A person who performs services as a volunteer for a school district and who has direct supervisory authority over the student with whom the person engages in conduct prohibited under Iowa Code section 709.15(3)(a).
- A person who provides services under a contract for such services to a school district and who has direct supervisory authority over the student with whom the person engages in conduct prohibited under Iowa Code section 709.15(3)(a).

"School employee" does not include a student enrolled in the school district. - Sadomasochistic abuse of a minor for the purpose of arousing or satisfying the sexual desires of a person who may view a depiction of the abuse.

 person who may view a depiction of the nude minor.

⁸ **"Visual depiction of a minor"** includes any visual depiction that has been created adapted, or modified to give the appearance that an identifiable minor⁹ is engaged in a prohibited sexual act or the simulation of a prohibited sexual act.

⁹ "Identifiable minor" is a person who was a minor at the time the visual depiction was created, adapted, or modified, or whose image as a minor was used in creating, adapting, or modifying the visual depiction and is recognizable as an actual person by the person's face, likeness, or other distinguishing features. Proof of the actual identity of the identifiable minor is not required.
