# Stakeholder Session Goals

- Iowa Medicaid, MCO, and Vendor support to providers.

# HHCS EVV Implementation Timeline

Presented by CareBridge

- July 1, 2023
  - Communications will begin being disseminated around EVV Home Health onboarding
  
- September 25, 2023-October 23, 2023
  - Live, virtual training. On-demand will ALWAYS be available.
  
- October 1, 2023
  - System Availability
    - Will request volunteers for early adopter commitments during stakeholder session
  
- January 1, 2024
  - Claims denial
  - Potential Sanctions for non-compliance
