The Wright County HIP was developed following the CHNA summary review. The plan was developed from feedback from the Wright County Transitions of Care committee, community members, ISH Clarion foundation board, ISH Clarion Hospital board, ISH Belmond foundation board, Wright County Public Health, Wright County Board of Health, and ISH Belmond Hospital board. The priorities were developed following feedback from the multiple avenues where the CHNA was shared. The strategies and goals were identified from a sub-group of the TOC committee. Data was collected from the county wide survey using paper and digital reach. This team used the CHNA and additional resources to base this determination. The resources they utilized included; CDC statistics, County Health Rankings and Roadmaps, Wright County Health Equity Report Card, US Census, Federal Financial Institution Examination Council Health Indicators Warehouse, Behavior Risk Factor Surveillance Systems, HRSAQ-area Health Resource File, American Community Survey, and National Center for Chronic Disease Prevention and Health Promotion. The responsible parties have been identified for a portion of the priorities while some of the goals and action items do not have a party yet identified and will evolve into a group or program as time progresses. The communication plan for the CHIP for Wright County includes sharing at the following meetings in April of 2023: ISH Clarion board, ISH Belmond board, Wright County TOC committee, Wright County Public Health, Wright County Board of Health, the Wright County website, and ISH website.
