# **Tertiary Care Psychiatric Hospital Workgroup**

HF 2456 sec 18 directs Department of Human Services, Department of Inspections and Appeals, representative members of the Iowa hospital association, managed care organizations, the national alliance on mental illness, the mental health institutes and other affected or interested stakeholders to review the role of tertiary care psychiatric hospitals have in the array of mental health services. The work group is to establish the roles and responsibilities of tertiary care psychiatric hospitals, determine the viability of the mental health institutes becoming a tertiary care psychiatric hospital, examine potential sustainable funding available, and determine admission criteria. The work group is to create recommendations for tertiary care psychiatric hospitals and provide those recommendations to the governor and general assembly by November 30, 2018.

- Identify viability of providers and potential sustainable funding,
- Determine criteria for who can receive services, and
- Develop recommendations to overcome EMTALA and forensic barriers
