(Des Moines, Iowa) – The Department of Human Services (DHS) ej kiō lelok jibañ in aoleben Medicaid ñan aoleb rūtto ro remaron tōbrak im rej citizen in Palau, Marshall Islands, im Federated States of Micronesia im rej jokwe ilo Iowa iomwin kakien ko jejelā rej Compacts of Free Association (COFA).

Kakien eo an 2021 Consolidated Appropriations Act (CAA) emōj kar jaiñ ñan kakien eo an federal ilo Tijemba 27, 2020, im ear kōmelim joortoklik in Medicaid ñan aoleb rūtto in COFA. Rūtto ro an COFA rej aikuj wōt tōbare aoleben mennin aikuj ko ñan aer maron tōbrak ñan Medicaid (waanjonok, joñan jemlok in kolla ko im mennin aikuj ko ñan burokraam eo an Medicaid) ñan aer maron tōbrak ñan aoleben jibañ ko an Medicaid.

Emōj an DHS kōkkāāle kakien ko an ñan maron tōbrak ilo Medicaid im jikin jermal ko rej kōmelim oktak in an federal ilo joortoklikin Medicaid. Kakien ko an federal moktalok ear kōmman bwe armij in COFA ro rar emakūt tōk bwe renjab maron ebōk joortoklik in Medicaid jen 1996.

Oktak in kakien in ej kaju jelōte rūtto in COFA. Mennin ekoba aoleb rūtto in COFA ro remaron tōbrak im rej jokwe ilo Iowa im rej kiō ebōk joortoklik in Medicaid eo edik joñan im an ien idin ak ro rar kateruru ñan an wonmaanlok Medicaid, bōtab rar jab teru ñan aoleben joortoklik in Medicaid jen ien eo ear jañij kakien eo ilo Tijemba 27, 2020.

Objij eo ej bwinne ke emaron kōtaan 300 im 400 rūtto in COFA reñaj maron tōbrak ñan Medicaid kin oktak in kakien in.

Ejellok oktak ilo maron tōbrak ñan Medicaid ñan ajiri ro an COFA (diklok jen 21 yiō) Ilo Iowa, ajiri ro an COFA emōj aer maron tōbrak ñan aoleben jibañ ko an Medicaid jen 2010 ekkar ñan jekjekin aer kar deloñ tōk Amedka.

DHS enaj bōk kōmadmōd ko laajrak ñan lolorjak an wōr joortoklik in Medicaid ñan rūtto in COFA ro remaron kiō tōbrak ñan aoleben jibañ ko an Medicaid:

Mokka jen jemlokin Babode, ablikajon ko rar jab tōbrak renaj loe juon kojellā ilo mael ej kōmelele jemlok eo ekāāl ñe ejab kajitōke melele ko jet objij eo aikuji.
- Ñan ablikajon in Medicaid ko rar bael ibben objij eo ñan Maaj 31, 2021, rūtto in COFA ro rej ioon aoleb mennin aikuj ko jet ñan maron tōbrak ñan Medicaid, renaj loe joortoklik eo rej aikuji ñan jibañ kolla wonnen muri in taktō ko jen Tijemba 2020.

- Ñan ablikajon in Medicaid ko rar bael ilo Ebrol 1, 2021, im tōkelik, rūtto in COFA ro remaron naj tōbrak ñan Medicaid jino jen raan ko maanlok wōt ñe renaj bed iomwin laajrak eo ej kōmelim joortoklik jen raan ko moktalok (juon ribōrōrō ak kirae ak juon armij ej jokwe ilo imōn rūtto ro rej lali im ewōr an laijen iomwin Iowa Code Chapter 135c) im ej ion aoleb mennin aikuj ko jet ñan maron tōbrak.
