(Des Moines, Iowa) – Kempahn pali en Apwalih Aramas ansou wet kihkidahr epwel unsek oang pali en Roson mwahu oang koaros aramas loud me wia towe mehlel en Palau, Mwahsel, oh pil kahndeke kapatapat en FSM me koukouson nan Iowa sang inou me kouada Mininmin Saledeke(COFA)

2021 Kosonned me kapatahpene kohdahn mwohni koaros kamanamanla sang govenment lap ni Decembe 27, 2020 me pil mweidoahnghehr irail tohn wehi sang COFA en kak iang ale Medicaid. Aramas laud koaros en COFA pahn udahng aniki pwung oh mehlel en sapengala peidak anahn koaros oang iang alehdi sawas en roson mwahu koaros sang Medicaid(karasepe: wen mwohni kin alahdi oh soangoan sawas en rosonmwahu en Medicaid me anahnepe mie).

DHS pil kihdahier ire kapw oahng Medicaid duen koasoandi oh ireh kan me pahn mweidehng ire pwukat en wekidekla oang doadoahngki sawas en Medicaid. Federal Kosonned kei nan pahr 1996 me katokehdihier towe mehlel en COFA sang Medicaid sawas .

Wekdeklahn koasondih wet kioang ehr kahpwal oang aramas laud pahn COFA. Ire wet leloang ehr koaros COFA me kin koukouson nan Iowa me kin iang ale sawas oang ekis emergency Medicaid sawas de me pil pekihier sawas oahng Medicaid, ahpw sawas wet sohte kamanamanla pwehki koasoandi de kosonned me wekdekla in December 27, 2020.

Kempah wet lemlemehk me nan pwungen 300 oh 400 COFA aramas laud me pahn alehdi sawas en Medicaid sang wekdeklahng koasondi de kosonned wet.

Sohte wekdedlahiou sang Medicaid oang seriCOFA seri (pahn angin sounpar 21). Nan wein Iowa, serihn COFA kin iang alehdi sawas koaros en Medicaid sang te nan pahr 2010 pwehki arail ahniki pwung en emen en pedelong on kouson nan ehu wehi tohrohr.

DHS pahn wiahier wiepe konehng koaros me pahn kamehlele me Medicaid sawas oang COFA koaros me kakehr alehdi pahn kohieng irail ni sawas en Medicaid unsek.

- Ma nein emen COFA Medicaid pekipek alahda nan Kempah wet sang December 2020, oh January 2021 sohte kamanamanla oang sawas en Medicaid pwon pwehki irair en towe mehlel en wehi, kempah wet pahn pwurehng alehda pekipek wet oh kadoropwe i pwehn epwelda. Ni imwin sounpwong en Pebweri, koaros me neirail doaropwehn pekipe sohte epwela pwehki koasoandihn rahn teio pahn alehdi iren kaweid kapw nan sapwelimarail wasahn kouson de address me pid koasondi kapw oang ni Kempahn sawas wet.
- Doaropwehn pekipek koaros oang sawas en Medicaid me audaudahr ni Kempah wet sang Mahs 31, 2021, oang aramas laud nan COFA me pwungehr oang peidek anahn koaros nan Medicaid, pahn alehdi sawas me pahn pwainla sawas en roson mwahu sang Mahs pwurla lel December 2020.

- Pekipek in sawas me pahn wiawi ni April 1, 2021, oh pil mwuhr, me laud koaros me mih pahn COFA pahn kak iang alehdi pwei sahpaht en Medicaid sawas ihte ma irail iang mih pahn ire me mweidehng irail en iang(me liseian, de neitiklahr de koukouson nahn wasahn apwalih me likeilaplahr kan me aniki pwung oh manaman pahn Kosonned Koasondi en Chapter 135c nan Iowa) oh pil kapwaiadahier iren peidek pisetik koaros.
